PARTICIPATION AGREEMENT

The AM First Radio Network is a new service of Broadcast Management Services, Inc. BMS Inc. has reached an agreement with WestwoodOne Satellite Services to provide satellite delivery of participating radio programs which broadcast on KCAA AM-FM Radio.

This agreement will make participating KCAA programs available to thousands of radio stations on the AMC-8 Satellite. The agreement does not guarantee that other stations will broadcast your program. Instead, it guarantees satellite delivery of your program to stations that choose to broadcast it.

WestwoodOne describes itself as the national-facing arm of Cumulus Media, reaching 245 million people each week through 454 owned-and-operated radio stations in 90 US media markets, with distribution to more than 8,200 broadcast radio affiliates and numerous digital channels.

BMS will launch the AM First Radio Network on May 2nd 2016. The cost to broadcast previously recorded one hour program on the WWO satellite is \$55. The cost to broadcast one hour live program is \$80. WWO requires BMS Inc. to make quarterly payments in advance.

BMS Inc. has a one year agreement with WWO, so our agreement with broadcasters will have the same prepayment requirement and term. WWO only allows programs that air on KCAA to participate.

Participating radio programs will be uploaded to WWO's satellite facilities for scheduled broadcast on the AMC-8 Satellite. This makes your program available on XDS Satellite receivers in the WestwoodOne group.

Stations that choose to become your affiliate will download your program to their local XDS receiver on a predetermined day and hour (usually between 2 and 5 a.m.) for replay by the station at a later date and time. Live programs will air simultaneously at the hour and time they are produced in the KCAA studios.

This is a satellite distribution agreement that makes your program available to other stations that can receive content from the AMC-8 Satellite.

The cost to participate in this self syndication opportunity is \$55 per hour for pre-recorded programs and \$80 per hour for live programs. This cost is in addition to the cost of your current broadcasting agreement with BMS/KCAA.
